REQUIRED VERIFICATIONS FOR MEDICAID APPLICATIONS

The following is a list of information that will be required for the Medicaid application. One form of identification is needed for each category in numbers 1-4, you do not need all of the items.

If you are having difficulty in obtaining any of the items on this list, please call me at the number above.

- 1. Social Security cards for yourself and, if married, for your spouse.
- 2. Proof of identity. One of any of the following:
 - a. driver's license
 - **b.** state identification card
 - c. voter registration card
 - d. U.S. Passport
 - e. credit card with signature
 - f. doctor or medical record.
 - **g.** Any other picture identification if none of the above are available.
- **3. Proof of age.** You must provide <u>one</u> of the following for yourself and, if married, for your spouse:
 - a. Birth certificate
 - **b.** Baptismal record
 - c. Insurance policy
 - d. Marriage Certificate
 - e. Military discharge papers
 - f. Draft card
 - g. U.S. passport
 - h. Driver's license
- 4. Proof of residence.
 - **a.** For an individual in a nursing home, no proof will be required.
 - **b.** For the spouse, a rent receipt, mortgage book, or deed may be required.

- **5. Utilities, home insurance and property taxes.** For married couples you must provide your last receipt if you pay any of the following:
 - **a.** Telephone
 - **b.** Gas
 - c. Electric
 - d. Water
 - e. Sewer
 - f. Home insurance
 - g. Property taxes
- **6. Proof of income.** These include the following:
 - **a.** Last four to six weeks paycheck stubs if you or your spouse is working.
 - **b.** Court support order if there is support being given.
 - c. Benefits check.
 - **d.** Social Security benefit letter, which is generally received in December for the current year
 - e. Rental income.
 - f. Pension stub showing gross and any amounts deducted.
 - g. Proof of income from an annuitized annuity
 - **h.** Railroad retirement
- **7. Life Insurance.** You must provide the following if you have insurance on yourself and/or your spouse:
 - a. Insurance policies.
 - **b.** Statement from insurance company showing present cash value of any life insurance policy.
- **8. Medicare card.** Both spouses, if married.
- **9. Medicare Supplement** card, <u>both sides</u>, and current Medicare Supplement bill for each spouse or individual.
- **10. Proof of assets/resources.** We must provide the following:
 - **a.** Last three months' bank statements (Medicaid may ask for more)

This includes statements for:

- Checking (including check register for past year, if available)
- Savings
- CD's
- Money Market Accounts
- Christmas Club Accounts
- Credit Union Accounts
- Any other accounts containing funds

- **b.** Statement showing the amount of assets as of the snapshot date (Married Couples Only). The snapshot date is the first day of a thirty day period that an individual enters a hospital or nursing home. Please talk to us before trying to determine this date.
- **c.** Copies of stocks and bonds or brokerage accounts.
- **d.** Motor vehicle titles.
- **e.** Real estate deeds owned during the last three years. This includes life estates.
- **f.** Annuity Contracts, including information as to whether the contract has been annuitized.
- **g.** IRA, 401(k) or other retirement account statements
- 11. Proof of any gifts or transfers of property during the last five years.

IMPORTANT!!!!! When in doubt as to whether something was a gift or transfer discuss it with me!

- 12. Trust Agreement and information regarding distributions from the Trust (if any).
- **13.Additional verifications.** Usually the caseworker will request the last three to five years federal income tax returns, and may ask for other proof.
